Members of the EMS Study Committee are from all areas of Hamilton County and have expertise necessary to evaluate our community's needs.


- County-wide EMS and hospital experts participated

City initiates study of fire-based EMS

■ Melcher, Long explain how committee will be formed in search of solution

After a decision was made by Hamilton County commissioners Jan. 2 to discontinue emergency medical management of the county's emergency medical services as of Oct. 1, city leaders voted last week to pursue their own study of a fire-based ambulance service.

City Administrator Rick Melcher and Mayor Dave Long explained the initial intentions of the study, which will be focused on how Aurora might merge the ambulance service into the city's volunteer fire department.

"Our focus is fire-based and that's all we want to study," Long stated. "We're not saying it's the answer, but it's the one that we want to study. If another group wants to pursue another one, fine, but then we'll have a hard time looking at will specific conditions. The city's fire-based study will begin with a committee now being established, but not one that the city plans on organizing itself. According to Melcher, they hope an initial combination of city, county and hospital officials can begin hand-picking individuals to fill out the committee. Both entities have been invited to participate, though their involvement had not been confirmed as of this writing. (See [STUDY](#), A1)

City begins study on fire-based EMS plan

■ Long says goal to be complete by Oct. 1

City leaders reported this week that a committee has been assembled to look into the possibility of combining the Aurora Volunteer Fire Department with the county ambulance service.

Knowing that the county's role as an owner-manager of the local EMS service is set to end Oct. 1, Mayor Dave Long said discussions have begun with hopes and expectations that a new plan will be ready before October.

"We've had our first meeting in relation to emergency medical services," Long said. "We formed a committee that I'm going to refer to as the Emergency Medical Services Committee. This committee was formed by individual institutions that picked the members on it."

Long and other city officials went directly to groups they thought would be connecting to the emergency service that Memorial Community Health, Aurora Rural Fire District, Hamilton County Sheriff, Aurora Police Department and representatives of villages within Hamilton County.

Those in attendance at the first meeting included Long, city administrator Rick Melcher, city council members Dick Phillips, Denise Anderson and Wayne Robiner, Aurora police chief Paul Graham, and Sub-Marshal representing the Aurora News-Register.

City's EMS study focus shifts to jurisdiction, possible partnerships

■ Staffing levels, handling of transfers on Monday agenda

The Aurora EMS Study Committee discussed the need to define the service jurisdiction a fire-based ambulance system might serve as well as potential partnerships needed to reach that goal during its hour-long meeting Thursday.

Facilities issues that asked some baseline questions of the group, explaining that the options discussed will help lead to potential answers, with each discussion summarized in a final report expected by the end of August.

"Each agenda will cover a major topic," said Wolf, a community engagement director with RJO Consulting. "What we're doing with the plans we're making, information and questions, they will be presented at a future meeting and will be fully addressed in the study. So we're kind of writing this in real time here. It may seem like a round-pinning right now, but by the time we're done with these meetings you can step back and see a lot of things that we're set up to do that very well." Mayor Dave Long continued, "We have relationships with the smaller communities where they help each other and we need to keep that type of set-up. That's very important. The relationship with the rural fire ambulance people, we have to have that."

Aurora Fire Chief Tom Cox noted that the existing ambulance service responds to every call in the county, regardless of what fire district the call comes from. County commissioners voted earlier this year to end ownership and management of that service effective Oct. 1, which is what prompted the city to initiate the study of a fire-based service. COMMITTEE RECOMMENDATIONS



Recommendations are based on the supermajority consensus of committee members.

The committee found a way to more effectively operate an EMS service that brings in more private dollars to underwrite a top-quality service.

Committee members did not want to compromise the health and safety of Hamilton County residents in any way.

Recommendations of the EMS Study Committee

1. Pursue a license from the State of Nebraska to operate a fire-based EMS.
2. Apply for eligible grants for equipment, personnel, and other operational costs of running an EMS.
3. Create an EMS operation that can handle up to 950 calls per year.
4. Actively pursue more transfers than is currently being handled by Hamilton County.
5. Have a staff of one full-time director, eight paramedics, and target a part-time staff of 10 that are qualified at minimum as EMTs.
6. Initially continue using EMS Billing Services as the billing service provider, but continuously evaluate other competitive options.
7. Consider creating a temporary living quarters for full- and part-time staff while on shift at the existing EMS building or at a nearby location to decrease response times and maximize the recruitment and retention of full time employees.
8. Consider billing for standby services at public events, not sponsored by the City of Aurora.

CONCERNS WITH PRIVATE SERVICE OPTIONS



EMS CITIZEN STUDY GROUP FINAL REPORT

The 2017 EMS Citizen Study Group Final Report does not provide certainty on the quality or level of EMS service Hamilton County residents will receive.

The 2017 EMS Citizen Study Group Final Report did not adequately compare itself with peer cities.

- Why did peer cities studied by Aurora's EMS committee drop their private sector EMS providers and go back to public provided EMS service?

The report does not make clear what happens to our publicly funded ambulances.

- Are Hamilton County residents being asked to provide corporate welfare to a private service by giving away our ambulances?

All of the peer cities reviewed by the Aurora EMS Study Committee have abandoned the use of private ambulance service providers and reverted back to a public EMS service model.

RESCUE 28, INC. PROPOSAL

Rescue 28, Inc. has only been incorporated for one month and has no track record.

- Rescue 28, Inc. has no principal address on file with the Nebraska Secretary of State.
- Rescue 28, Inc. has no known clients, no known staff, no known EMS equipment, and no known experience in operating an ambulance service.

Rescue 28, Inc. proposes to cut current EMS staffing by more than half and reduce overall response service.

- Proposal reduces EMS staff from 9 to 4 professionals.
- Proposal reduces average annual call responses from 750 to 575 per year.
- Proposal eliminates stand-by services for school and community events.
- Proposal underfunds future equipment needs.

Rescue 28, Inc. seeks a taxpayer subsidy to operate in order to guarantee a profit for its investors.

- The proposal demands that its contract be renegotiated every year.
