# Aurora, Nebraska April 13, 2021

### 7:30P.M. PUBLIC HEARING:

Mayor Seeman opened the duly advertised Public Hearing: to hear public comments regarding amending Ordinance No. 1110, the Zoning Ordinance to the City of Aurora, Nebraska and to amend the Land Use Plan, a part of the Comprehensive Plan, Ordinance No. 1109, to reflect changes in zoning for the property located at 1112 & 1114 14th Street & 1403 L Street (South 41' of West ½ of Lot 2, Lot 3 and West ½ of lots 4 and 5, Block 16, Aurora Original Town, City of Aurora, Hamilton County, Nebraska, from R/O, Residential/Office District Designation to C1, Central Business District Designation.

Mayor Seeman asked if there was anyone present who wished to speak in opposition of the recommendations and there was no one. The Mayor then asked if there was anyone present that wished to speak in support to the changes and Bill Gowen spoke. There being no one else present that wished to speak in favor of or in opposition to the request the Mayor declared the public hearing closed.

Councilor Dunn seconded the motion. Voting Aye: Bartling, Dunn, Phillips, Lohrmeyer, Lackore and Roblee. Nay: None. The motion carried.

Councilor Dunn moved to approved Resolution 21-06 setting the rates for the Aquatic Center. Councilor Roblee seconded the motion. Voting Aye: Dunn, Phillips, Lohrmeyer, Lackore, Roblee and Bartling. Nay: None. The motion carried and the following resolution was declared passed and adopted.
