## Aurora, Nebraska February 22, 2022

A total of seven lots. Councilor Lackore moved to approve the Administrative Subdivisions for Lots 1, 2, 3, 4, 40, 41 and 42 Streeter's Fourth Addition, City of Aurora, Nebraska. Councilor Dunn seconded the motion. Voting Aye: Dunn, Lohrmeyer, Lackore Roblee and Bartling. Nay: None. Absent and not voting: Phillips. The motion carried.

City Attorney requested the Council go into closed session discuss potential litigation. Mayor Seeman stated that no actions could be taken during closed session and that the closed session was for informational purpose only. Councilor Roblee moved the Council go into closed session, for the protection of the public interest, to discuss potential litigation. Councilor Dunn seconded the motion. Voting Aye: Lohrmeyer, Lackore, Roblee, Bartling and Dunn. Nay: None. Absent and not voting: Phillips. The motion carried and the City Council went into closed session at 7:59pm.

Councilor Roblee moved to adjourn the closed session. Councilor Lackore seconded the motion. Voting Aye: Lohrmeyer, Lackore, Roblee, Bartling and Dunn. Nay: None. Absent and not voting: Phillips. The motion carried and the closed session was adjourned at 8:08 pm.
