Councilor Roblee moved for final adoption of Ordinance No. 1181. Councilor Dunn seconded the motion. The Mayor then stated the question, "Shall Ordinance No. 1181 be passed and adopted?" Upon roll call vote, the following Councilors voted Aye: Bartling, Dunn, Phillips, Lackore and Roblee. Nay: None. Absent and not voting: Lohrmeyer.

The passage and adoption of said Ordinance having been concurred in by a majority of all members elected to the Council was by the Mayor declared passed and adopted and the Mayor in the presence of the Council signed and approved said Ordinance and the Clerk attested the passage and approval of same and affixed her signature thereto. Said Ordinance shall be preserved and kept in a separate and distinct volume known as the Ordinance Record of the City of Aurora, Nebraska and same be incorporated herein by reference.

The Clerk presented a proposed Resolution of Necessity for the creation of Storm Sewer District No. 24-1 for Mission Critical Subdivision. The City Clerk advised the Mayor and City Council it would be necessary to give notice of the proposed Resolution of Necessity and Notice of Hearing on the proposed resolution by publication two consecutive weeks prior to the hearing. A hearing would then be held on March 12, 2024 and following such hearing the Resolution of Necessity could then be considered for passage by vote of the City Council.

A RESOLUTION DECLARING THE NECESSITY OF CONSTRUCTING ADDITIONS AND IMPROVEMENTS TO THE CITY'S STORM SEWER SYSTEM; CREATING STORM SEWER DISTRICT NO. 24-1 OF THE CITY; MAKING REFERENCE TO AND APPROVING PLANS AND SPECIFICATIONS; APPROVING THE ENGINEERS' ESTIMATE OF COSTS; PROVIDING FOR THE ISSUANCE OF BONDS, WARRANTS AND NOTES, DETERMINING IMPROVEMENTS TO BE GENERAL PUBLIC IMPROVEMENTS NOT OF SPECIAL BENEFIT TO PROPERTY WITHIN SAID DISTRICT AND PROVIDING FOR THE EFFECTIVENESS OF THIS RESOLUTION

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF AURORA, NEBRASKA, AS FOLLOWS:

Section 1. The Mayor and City Council hereby find and determine that it is necessary and advisable to construct additions and improvements to the City's Storm Sewer System consisting of the following:

BEGINNING AT MANHOLE 1 LOCATED 15' WEST AND 4' NORTH OF THE NORTHWEST CORNER OF LOT 4, MISSION CRITICAL FIRST ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY, NEBRASKA. THENCE NORTHERLY WITH A 24" STORM SEWER PIPE 85' TO A TERMINATION POINT AT A FLARED END SECTION. THENCE SOUTHERLY FROM MANHOLE 1 WITH A 24" STORM SEWER PIPE 39' TO A TERMINATION POINT AT A FLARED END SECTION. THENCE NORTHEASTERLY FROM MANHOLE 1 WITH AN 18" STROM SEWER PIPE 15' TO AN INLET. THENCE NORTHERLY WITH AN 18" STORM SEWER PIPE 40' TO A TERMINATION POINT AT AN INLET.

A 36" STORM SEWER PIPE BEGINNING AT A POINT 6' WEST OF THE SOUTHWEST CORNER OF LOT 2, MISSION CRITICAL FIRST ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY, NEBRASKA. THENCE SOUTHERLY 53' TO MANHOLE 2. THENCE EASTERLY WITH A 42" STORM SEWER PIPE 354' TO AN INLET/MANHOLE LOCATED 348' EAST AND 53' SOUTH OF THE SOUTHWEST CORNER OF LOT 2, MISSION CRITICAL FIRST ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY, NEBRASKA. THENCE EASTERLY WITH A 42" STORM SEWER PIPE 103' TO MANHOLE 3 LOCATED 53' SOUTH OF THE SOUTHEAST CORNER OF LOT 2, MISSION CRITICAL FIRST ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY NEBRASKA. THENCE EASTERLY WITH A 48" STORM SEWER PIPE 452' TO MANHOLE 4. THENCE NORTHERLY WITH A 48" STORM SEWER PIPE 60' TO A TERMINATION POINT. THENCE SOUTHERLY FROM MANHOLE 4 WITH A 60" STORM SEWER PIPE 10' TO A TERMINATION POINT.

AN 18" STORM SEWER PIPE BEGINNING AT AN INLET/MANHOLE LOCATED 348' EAST AND 53' SOUTH OF THE SOUTHWEST CORNER OF LOT 2 MISSION CRITICAL FIRST ADDITION TO THE

CITY OF AURORA, HAMILTON COUNTY, NEBRASKA. THENCE NORTHERLY 43' TO A TERMINATION POINT AT AN INLET.

A 24" STORM SEWER PIPE BEGINNING AT MANHOLE 3 LOCATED 53' SOUTH OF THE SOUTHEAST CORNER OF LOT 2, MISSION CRITICAL FIRST ADDITION TO THE CITY OF AURORA, HAMILTON COUNTY, NEBRASKA. THENCE NORTHERLY 60' TO A TERMINATION POINT AT AN INLET.

Section 2. For purposes of constructing said additions and improvements, there is hereby ordered created Storm Sewer District No. 24-1, which shall include certain property within the City fully described as follows:

Section 3. Reference is hereby made to the plans and specifications (the "Plans") for said additions and improvements which have been prepared by JEO Consulting Group Inc., special engineers for the City, and which, together with the estimate of total cost for said additions and improvements have been filed with the City Clerk prior to the proposing of this resolution.

Section 4. The engineer's estimate of total cost for the proposed Storm Sewer System additions and improvements for said District is \$461,090, which amount does not include interest cost, cost of issuance and other expenses of the City.

Section 5. It is hereby found and determined that such improvements are of general benefit to the City and that no special assessments shall be levied against the property in the District. Temporary financing may be provided through the issuance of bond anticipation notes as provided by Section 10-137, R.R.S. Neb. 2007. Said additions and improvements shall be financed on a permanent basis by the issuance of the City's general obligation storm sewer bonds issued pursuant to Section 17-925, R.R.S. Neb., as amended.

Section 6. This resolution of necessity shall be in force and effect from and after its adoption as provided by law.

Councilor Phillips moved to adopt Resolution 24-06 for Mission Critical Subdivision. Councilor Lackore seconded the motion. Voting Aye: Dunn, Phillips, Lackore, Roblee and Bartling. Nay: None. NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Aurora, Nebraska, that the following question be submitted to the qualified electors of the city at the next election to be held within the City, that being the Primary Election to be held on May 14, 2024:

Shall the Governing Body of the City of Aurora, Nebraska impose a sales and use tax of one and one half percent (1 ½%) upon the same transactions within the City of Aurora, Nebraska on which the State of Nebraska is authorized to impose a tax commencing October 1, 2024, and further should the City of Aurora, Nebraska increase its budgeted restricted funds for fiscal year 2024-2025 by \$1,000,000 which is a 23.57% increase over the current year's restricted funds according to the 2023-2024 adopted budget, to fund the reduction of property tax within the city of Aurora, Nebraska, the Economic Development including Infrastructure Extensions and Rehabilitation Projects within the City of Aurora, Nebraska, the Recreation Activities within the City of Aurora, Nebraska, the Public Safety within the City of Aurora, Nebraska, the civic and social activities within the City of Aurora, Nebraska, and to maintain the level of Municipal Services desired by the citizens of the City of Aurora, Nebraska.

BE IT FURTHER RESOLVED that the City Clerk is hereby authorized and directed to submit a Certified Copy of this resolution to the Election Commissioner of Hamilton County, Nebraska immediately.

RESOLUTION 24-03

WHEREAS, the City of Aurora, Nebraska, by and through its Water Department, provides fresh water to consumers, both residents and non-residents of the City;

AND WHEREAS, Section 51.09 of the Municipal Code of the City of Aurora provides that the City Council has the power and authority to fix the rates to be paid by the Consumers for the use of water from the Water Department; and

WHEREAS, Section 51.10 of the Municipal Code of the City of Aurora provides that all water consumers shall be liable for the rates, fees, and other charges, as the Council shall by resolution provide;

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL that the meters for recording the usage of such services be read monthly and that bills for said services be prepared, mailed, and collected on a monthly basis as determined from the above meter readings, or estimates when necessary. The established rates shall be effective for the next twelve months beginning with the April billing at the following rates:

LOCATIONS SERVED BY ONE COMMON WATER METER

Locations served by one common water meter which are divided into multiple housing or business units or which serve more than one business or entity shall be assessed the minimum charge for each unit, business, or entity served.

NON-RESIDENT USERS

Each non-resident user shall pay two (2) times the rate for water use fees as established for residents (per unit if multiple units are served by one common water meter).

CAPITAL MAINTENANCE USE FEE

A \$2.00 monthly capital maintenance use charge shall be assessed to each water consumer in addition to the regular rates charged for use as set forth in this section.

RESOLUTION 24-04

WHEREAS, the City of Aurora, Nebraska, provides garbage collection services to domestic and commercial residents of the City.

AND WHEREAS, Section 91.06 of the Municipal Code of the City of Aurora provides that fees for such service shall be established by resolution of its Council.

BE IT THEREFORE RESOLVED BY THE MAYOR AND COUNCIL that the following fees shall be assessed for such service:

RATES FOR 2024

A. Service with Toter. Residential or business establishments shall be charged for each residential unit or business establishment \$14.65 per month for one toter one pickup each week plus \$3.86 for each additional toter. Each additional weekly pickup is an additional \$10.73 per month plus \$3.86 for each additional toter picked up.

B. Service with 2-Yard Containers. Customers utilizing 2-yard containers shall be charged \$51.13 per month for each pickup per week, plus \$11.66 per month container rental.

Bills not paid by the tenth of the month, following billing, will be subject to the above rates plus a ten-percent (10%) service charge.

RATES FOR 2025

A. Service with Toter. Residential or business establishments shall be charged for each residential unit or business establishment \$15.09 per month for one toter one pickup each week plus \$3.98 for each additional toter. Each additional weekly pickup is an additional \$11.06 per month plus \$3.98 for each additional toter picked up.

B. Service with 2-Yard Containers. Customers utilizing 2-yard containers shall be charged \$52.00 per month for each pickup per week, plus \$12.36 per month container rental.

Bills not paid by the tenth of the month, following billing, will be subject to the above rates plus a ten- percent (10%) service charge. Service at the Waste Site

To accommodate City residents with items which are not collected from residences or commercial pickup points, the city provides a roll-off container at the waste site at the following rates:
