### New Applicants must have:

- Passed the City of Aurora Plumber's License Examination, and paid the examination fee of Twenty-Five Dollars (\$25.00).  
**or**
- Have a Master Plumber's License from a larger City in which the Aurora Public Works Director approves.  
**and**
- Include the Fifty Dollar (\$50.00) initial license fee payment.  
**and**
- Include a Surety Bond in the amount of Five Thousand Dollars (\$5,000).

All applicants must be approved at a regular City Council Meeting

ORDINANCE 10-302 SURETY BOND: Each person, firm or corporation shall be required to provide the Municipality with a personal surety bond in the sum of Five Thousand Dollars (\$5,000.00) signed by one or more sufficient sureties or a bond in a like amount from an approved corporate surety. The bond shall be conditioned that the licensee shall indemnify and hold harmless the City from all accidents, damage, liability, claims, judgments, costs, or expense caused by any negligence arising from a failure to adequately protect plumbing work, by unfinished, unskilled, or inadequate work or arising out of furnishing defective material.
